# **VOTE BY MAIL OR VOTE ON TUESDAY, NOVEMBER 5<sup>th</sup>!!!**

We arrived at these endorsements through a rigorous and democratic process whereby IBEW 684 is part of a couple Community Committees and some of our members participate at the local level through interviews, the Stanislaus/San Joaquin Construction Building Trades, Merced/Stanslaus/San Joaquin County Labor Councils, Northern Valley Labor Federation endorsement processes as well as at the state level through the California State Building Trades Council and/or the California Labor Federation. These processes include research on candidates and ballot measures, interviews of candidates and issues advocates, and votes by delegate and executive board bodies to determine whether a candidate or ballot measure should receive a labor endorsement.

Candidates must demonstrate that they support the values and work of IBEW Local 684, labor unions (as a whole) and our members. Our Union endorsed these candidates and initiatives, and we need you to vote for them.

If there is a race or issue that is not listed, but is on your ballot, it means candidates or advocates for the initiative did not seek or receive an endorsement from the local Building Trades Council and/or Valley Labor Federation or that of IBEW – Local 684 itself.

ELECTION DAY IS TUESDAY, NOVEMBER 5<sup>th</sup> 2024.

If you recently moved, changed your name, or want to change your political party, you need to re-register to vote. You should be registered to vote at least 15 days before an election. You can register to vote online at <http://registertovote.ca.gov/>
